

Green Procurement Policy

Introduction

With a strong commitment to supporting and promoting sustainable development by taking into account economic, social, and environmental dimensions, KCG Corporation Co., Ltd. (KCG) has established its **Green Procurement Policy** and **Green Procurement Guidelines** to serve as a reference for all stakeholders and to be integrated into operational practices.

KCG sincerely hopes that this policy and its accompanying guidelines will serve not only as a statement of intent in conducting business with corporate social responsibility (CSR) and environmental sustainability, but also as a reflection of collective environmental awareness. Through simple yet effective practices outlined in this policy, KCG aims to encourage behavioral change that can be integrated into daily routines, ultimately delivering positive impacts on the economy, society, and the environment.

Objective

This Green Procurement Policy is established as a guideline for KCG's business operations throughout the entire supply chain, with the aim of minimizing negative economic, social, and environmental impacts both in the present and in the future.

Green Procurement Policy

KCG shall carry out its procurement activities with consideration for the efficient use of resources, environmental impact, and environmental protection throughout the entire product life cycle. Procurement decisions—whether for goods or services—shall prioritize those that are the most environmentally friendly, while also taking into account their suitability for use, effectiveness, and cost-efficiency.

Definitions

- **Most Environmentally Friendly Products**

Refers to goods or materials that have the least impact on health and the environment when compared to other products in the same category throughout their entire product life cycle. This evaluation takes into account factors such as the type and source of raw materials, production processes, packaging, storage, transportation, handling, distribution, energy and resource efficiency in operations, as well as maintenance, waste management, and disposal throughout the product's life cycle.

- **Environmentally Friendly Services**

Refers to services that have the least impact on health and the environment when compared to other services in the same category.

- **Suitability and Effectiveness of Products or Services**

Refers to the extent to which the product or service meets the necessary and adequate functional requirements, both in the short term and long term.

- **Reasonable Price**

Refers to the consideration of price differences between environmentally friendly products or services, ensuring that such procurement does not result in a cost disadvantage to the company's operations.

Scope

This policy applies to all procurement of goods and services conducted by KCG, with the exception of items and services that are critically related to health, safety, and occupational health—such as medical treatment, pharmaceuticals, and essential safety protection equipment.

Implementation Guidelines

This Green Procurement Policy is intended to be implemented across all procurement activities involving goods and services. The scope of environmentally friendly procurement includes the following categories:

- Major appliances and office supplies
- Office and other furniture
- Computers and other electronic equipment and supplies
- Paper and paper products
- Vehicles and other transportation equipment
- Promotional materials and official publications
- Electrical and construction materials
- Facility management and cleaning services

To ensure effective implementation of this policy, the Procurement Department will work closely with all internal stakeholders across KCG, as well as with external vendors and suppliers, to promote and execute environmentally responsible purchasing practices.



Policy Review and Improvement

This Green Procurement Policy shall be reviewed and updated at least once a year to ensure its relevance and alignment with current conditions and emerging changes. We remain committed to continuously enhancing our operational standards.
