- 2. Purpose of collection, use, and disclosure of personal information: The Company collects, uses, and discloses personal information. and disclosing your personal information for the following purposes
  - To organize shareholder meetings participating in shareholder meetings and managing shareholder meetings, such as registering to attend meetings recording votes, etc.

- 3. Source of personal information: The Company receives personal information directly from the Stock Registrar.
- 4. Retention of personal information: The Company will retain your personal information for the period of time necessary to use the information in order to fulfill the purposes mentioned above, unless the law allows a longer retention period.

Rights of the data owner: The owner of personal data has the right to request access to or obtain a copy of personal data or to request disclosure of the acquisition of personal data without consent.
